Transported from Madhya Pradesh and Gujarat, where this variety is grown, they are graded to a particular size, and arrive at the Club courtesy our own member Mr Prakash Prabhu, who is into commercial production of this snack. Mr Prabhu says that the process for large scale production and home production differs a lot. MC is the only place in the city he knows of, that makes them fresh at this quality. I would love to know more of the process and try to adopt it in our production process at City Bakery, he adds. So next time that irresistible crispy flake of potato wafer goes crunch in your mouth, remember they have gone through a long journey and process to attain that right colour and right balance of crunch and crispiness.

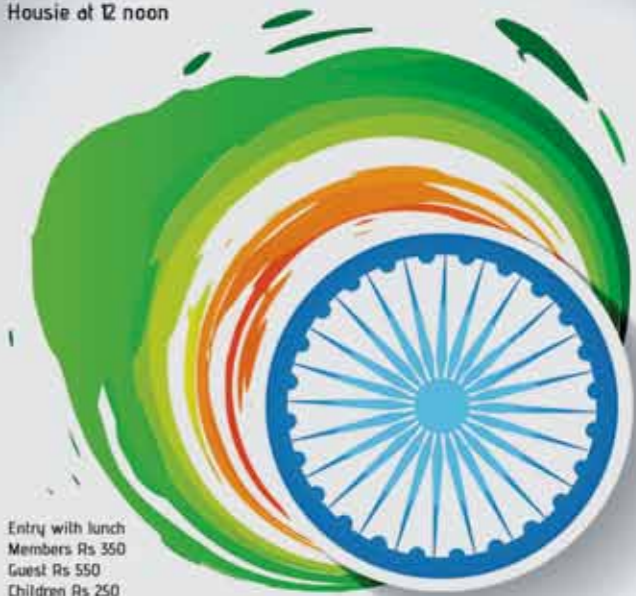
